## Subject: Urgent Appeal Regarding the Humanitarian Catastrophe in Al-Fashir, North Darfur

RE: A Humanitarian Tragedy in Al-Fashir: Children Dying from Hunger and Siege Dear Mr. Fletcher,

We write to you today with deep concern over the rapidly deteriorating humanitarian situation in the city of Al-Fashir, North Darfur. We are witnessing a genuine humanitarian catastrophe, as innocent children have lost their lives today due to hunger and malnutrition resulting from the siege imposed by the Rapid Support Forces (RSF) on civilians.

This tragedy is not only a stain on the conscience of the international community but also represents a grave failure of the humanitarian organizations and United Nations agencies that have so far been unable to negotiate, exert sufficient pressure, or ensure the safe delivery of humanitarian aid to the affected civilians.

#### We call upon your esteemed office to take immediate and decisive action to:

- Guarantee the safe and unhindered delivery of humanitarian assistance.
- Mobilize the international community to stop this ongoing tragedy; and
- Implement United Nations Security Council Resolution No. 2736, which calls for lifting the blockade on civilians in Al-Fashir.
